1. **PROMOTION PERIOD:** The Score Big Sweepstakes (the "Sweepstakes"), begins 12:00 AM (midnight) Pacific Daylight Time ("PDT") on August 26, 2020 and ends 11:59 PM Pacific Standard Time ("PST") on November 17, 2020 ("Sweepstakes Period").
2. **ELIGIBILITY:** Open to legal U.S. residents with a permanent address in Oregon or in that portion of Washington which is within seventy-five (75) miles of the Oregon/Washington border. Must be 18 years of age or older as of date of entry (must be 21+ to purchase alcohol). Employees of Safeway Inc./Albertson's LLC, Beaver Sports Properties, Oregon IMG Sports Marketing, and their parent, subsidiaries and affiliate companies ("Released Parties") as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The term "immediate family" includes legal guardians, children and legal wards, grandparents, and grandchildren, as well as "in-laws" (whether or not they live in the same household) as well as persons living in the same household. 3. **HOW TO ENTER:** There are two (2) ways to enter:

Limit five (5) Codes per person per transaction. Look for tailgate tags in-store identifying the participating products. Then, visit www.scorebigsweps.com (the "Website"), and follow the instructions to enter your Code, select if you are a Duck or Beaver fan, complete the online registration form and submit your entry ("Code Entry" or "Entry"). To be eligible for any drawing (each a "Draw"), Entries must be received prior to 12:01 AM PT on the Entry Deadline. Once an Entry is received, it will be valid for all remaining non-winning Draws for the duration of the Sweepstakes Period unless said entry has previously been selected as a winner.

Mail-in Entries will be entered into the drawing based upon the date received. Once an Entry is received, it will be valid for all remaining Draws for the duration of the Sweepstakes. You may not use more than one name or residential or email address. Only one (1) Entry per envelope. You must complete your own Entry. Mechanically reproduced entries and envelopes will be void. If Duck or Beaver is not specified, your entry will be void.

Entrants can only win one (1) weekly drawing during the Sweepstakes Period. Use of any automated, form filling, programmed or similar service or system will be void. Limit one (1) weekly prize per family or household and per e-mail address (regardless of whether more than one person uses the same e-mail address) during the Sweepstakes Period. All personal information submitted as part of the Sweepstakes will be used solely for the purpose of prize claim fulfillment and will not be disseminated to any third parties.
